Annual Operating Plans (AOPs) for 2019-2020

The AOPs for third(3rd) quarter were presented by Keith Goulding, Band Manager. The AOPs were discussed briefly, Council opted to move onto the AOPs for 2020-2021.

Annual Operating Plans (AOPs) for 2020-2021

In the absent of the Department Directors, Band Manager, Keith Goulding presented the new AOPs to council. The AOPs for the upcoming fiscal year are subject to change and will be reviewed once the new Strategic Plan is adopted by council. The new format of the AOPs was discussed and Councillors asked for clarification on the departmental AOPs and the following notes were made.

Community Development

The AOP for this department highlighted training that staff would like to complete. Councillor Odelle Pike advised that Newfoundland Aboriginal Women's Network (NAWN) has completed some of the training highlighted in the AOP. She suggested the staff to reach out to NAWN.

It is also mentioned that money was received for language initiatives.

Education and Training

The AOP for this department highlighted projects to be completed. Discussions from the AOP included: the Education Outreach Officers (EOOs) will enter the classrooms in Central; create a camp (such as Killdevil) in Central; and inform members of short-term and group-based training opportunities.

Finance

The AOP for Finance describes the objectives of the department, activities of the department and its staff. Councillors discussed the Compliance Manager and the knowledge he/she should possess which include: Process Flow Chart (PFCs); the Audit process; Financial Administrative Law (FAL); and Qalipu's four Financial Management Board (FMB) policies. Also discussed were the duties and responsibilities of the Compliance Manager which could include: leading the International Organization for Standardization (ISO) team; bank reconciliations; and journal entries.

Natural Resources

The department works on at least eighty(80) projects annually. The staff work diligently to secure funding each fiscal.

Operations

The AOP for Operations focusses on Health and several initiatives the Health Department is working on and plans to implement. Also noted here, is the fact that the SCIS cards are due to be renewed in 2022. Training for SCIS Clerks will be scheduled in April 2020.

Executive

The AOP presented to Council for the Executive Department focussed on Communications activities. Discussions took place regarding holding an election every four(4) years as opposed to the current three(3) year term. One main point included the fact that elections are costly and a four(4) year term would reduce that burden. Secondly, a four-year term would allow Councilors to fully learn the governance system and work on their campaign platforms. Following the election in 2021, Councillors wished to consider an election every four(4) years instead of three(3).

Budgets 2020-2025

Central Vice-Chief, Randy Drover, presented the 2020-2025 Budgets as Chair of the Finance and Audit Committee. He read a report which focussed on the first year of the budgets 2020-2021 and indicated that the forecast after that year will be subject to change based on the new strategic plan. Changes to the budget will also be a result of the ongoing organizational review.

Youth Representative Report

Jessica Saunders, Youth Representative distributed a report to Council. She highlighted what is happening in the community and presented on what the youth want.

Addition(s) to Agenda - Health Initiative

Minister Marc Miller released a report of funding for First Nations. Discussed was the report that indicated there may be funding for COVID-19. Discussions included: who qualifies for the funding; what qualifies; how do we apply for funding? Councillor Odelle Pike and Chief Brendan Mitchell participated in teleconference with Dan Kumpf, Director General, ISC Atlantic and Rory O'Connor, Assistant Director General.

Councillor Odelle Pike stated to Council her concern about Mental Health issues as well as anxiety and fear within the elders in her community. She stated the need for individuals in the community to help the vulnerable. Chief Mitchell advised that we need to identify items required for our members. He suggested forming a Committee to work with government.

Council Remarks

Councillors were asked to update each other on COVID-19 within their communities.

Andy Barker: We should look for flat rate of funding to pay for necessities such as mortgages.

Calvin Francis: Good in the community, there is a small group of community members. I support the

idea of funding to members. Have no knowledge of any individual needing anything.

Bern White: I have a large population of individuals in my ward. I can contact the Mayors and assist

the plans of town council.

Ivan White, SR: Flat Bay is isolated. I have a large population of single mothers and elders. I support

providing funding to these individuals.

Ivan J. White: In St. George's, we could contact groups and organizations in the community to

determine if they know what the needs are. Regarding Friday's weekly mailout to

members, I am pleased with the photos.

Odelle Pike: Concerned about the Mental Health of her community. We are excited about the online

information available to our members.

Keith Cormier: Finding out what is needed in each community is important. Concerned about

operational piece of individuals working from home and how the funding will be

dispersed.

Brian Dicks: Food and shelter is always a concern. Currently, I worry about safety of individuals.

There could be an Indigenous shelter for individuals concerned about their safety.

Jasen Benwah: I am isolated. I will be home on Monday and will then be isolated for another

fourteen(14) days. I hear that members are concerned about where money will come

from. The elders want to know who will help them.

Frank Skeard: We need to remember that we have members across the country. Funding to

individuals may be the equalizer. I suggest that we source a group of individuals to assist

such as senior students. GINU profiles may have these individuals.

Randy Drover: We could get a team of employees who are working at home to organize activities.

- A. Qalipu Mi'kmaq First Nation (also called Qalipu Mi'kmaq) is named in the Schedule to the First Nations Fiscal Management Act ("the Act");
- B. Council of Qalipu Mi'kmaq wishes to repeal the Qalipu Mi'kmaq Financial Administation Law, 2018 under section 9 of the Act and enact the Qalipu Mi'kmaq Financial Administration Law, 2020; and
- C. Council of Qalipu Mi'kmaq wishes to request the First Nations Financial Management Board ("the FMB") to review and issue a compliance approval of the Qalipu Mi'kmaq *Financial Administration Law*, 2020 under section 9 of the Act.

NOW THEREFORE BE IT RESOLVED that Council, for and on behalf of Qalipu Mi'kmaq, hereby:

- 1. authorizes and directs a representative of Qalipu Mi'kmaq to do the following:
 - a. to send a copy of this Council resolution to the FMB; and
 - b. to seek the informal assistance of FMB as available and appropriate in order to recommend to Council for enactment a financial administration law that complies with the requirements of the FMB's *Financial Administration Law Standards* established under the Act; and
- authorizes and directs a representative of Qalipu Mi'kmaq, to communicate with the FMB respecting the enactment of a new financial administration law by the Council;
- after enactment of a new financial administration law by Council under section 9 of the Act ("the Law"), authorizes and directs and directs a representative of Qalipu Mi'kmaq, to do the following:
 - a. to request the FMB to conduct a formal review and issue a compliance approval of the Law under section 9 of the Act; and
 - to deliver to the FMB all documents required by the FMB to conduct a formal review of the Law including any required original and electronic copies of the Law with evidence of enactment of the Law in a form satisfactory to the FMB;
- 4. after the FMB issues a compliance approval of the Law, authorizes the FMB to deliver an original copy of the Law enacted by Council for publication in the First Nations Gazette;
- authorizes the officers and employees of the First Nations Tax Commission to provide to the reviewer any relevant information the Commission has with respect to Qalipu Mi'kmaq;
- 6. confirms and agrees that Qalipu Mi'kmaq will indemnify, defend and hold harmless the FMB, its directors, officers and employees and every person acting on behalf of or under the direction of the FMB, its directors, officers or employees from any damages, costs, claims or causes of action arising from the conduct of a review of the financial management system under the *Financial Management System Certification Procedures*, from the reporting and consideration of the results of the review, from the giving of an



opinion respecting the review and from the issuance or revocation of a *Financial Management System Certificate* unless these damages, costs, claims or causes of action result from gross negligence or bad faith; and

7. confirms that this resolution was approved at a duly called and conducted Council meeting of Qalipu Mi'kmaq at which the required quorum of councillors was present throughout and that the required number of councillors approved the resolution at the meeting.

Council Resolution Authorizing a Request for Financial Management System Certificate BCR# 11-19-20

SUBJECT:

Authorization for officials of Qalipu First Nation to request the First Nations Financial Management Board to review the Qalipu First Nation's financial management system and to issue the Qalipu First Nation a Financial Management System Certificate

WHEREAS:

- **A.** Qalipu First Nation is named in the Schedule to the *First Nations Fiscal Management Act* ("the Act");
- B. Qalipu First Nation has enacted a financial administration law under section 9(1) of the Act and the law has been issued a compliance approval by the First Nations Financial Management Board ("the FMB") under section 9(1) of the Act; and
- **C.** Council of Qalipu First Nation wishes to request the FMB to review Qalipu First Nation's financial management system and issue the Qalipu First Nation a Financial Management System Certificate under section 55 of the Act.

NOW THEREFORE BE IT RESOLVED that Council, for and on behalf of the Qalipu First Nation hereby:

- 1. directs and authorizes Jodie Wells (jwells@galipu.ca), on behalf of the Qalipu First Nation to do the following:
 - a. to seek the informal assistance of the FMB as available and appropriate in order to receive a Financial Management System Certificate from the FMB;
 - to request the FMB to conduct a formal review of the Qalipu First Nation financial management system to determine if the Qalipu First Nation is, at the time of the review, in compliance with the FMB's *Financial Management System Standards* and to issue a Financial Management System Certificate to the Qalipu First Nation under section 50(3) of the Act;
 - c. to communicate with and provide all requested documents and information to the person authorized by the FMB to conduct the review of the Qalipu First Nation's financial management system on behalf of the FMB ("the reviewer") as required under the FMB's Financial Management System Procedures; and
 - d. to disclose to the reviewer any events subsequent to the date of the FMB's formal review of the Qalipu First Nation's financial management system that would materially impact any information provided by or on behalf of the Qalipu First Nation for purposes of the review of the Qalipu 's financial management system or to confirm to the reviewer that there are no subsequent events, as the case may be.

1 | Qalipu First Nation

- 2. directs and authorizes the following persons to cooperate with the reviewer as required in the FMB's *Financial Management System Certification Procedures*, when carrying out a formal review of the Qalipu First Nation's financial management system:
 - a. all councillors, officers, employees and auditors of the first nation; and
 - b. all contractors, agents or advisors of the first nation who are performing any services for or advising the first nation respecting its financial management system or who have custody or control over any first nation records;
- 3. confirms that the Qalipu
 - a. has enacted and brought into force the Qalipu First Nation Financial Administration Law, 2018 "the Law") for which the FMB has issued a compliance approval under section 9 of the Act, and
 - b. has not repealed the Law, and
 - c. has not amended or repealed and replaced the Law without requesting the FMB to review the amending or replacement law and issue a compliance approval under section 9 of the Act;
- 4. confirms and agrees that the Qalipu First Nation will indemnify, defend and hold harmless the FMB, its directors, officers and employees and every person acting on behalf of or under the direction of the FMB, its directors, officers or employees from any damages, costs, claims or causes of action arising from the conduct of a review of the financial management system under the *Financial Management System Certification Procedures*, from the reporting and consideration of the results of the review, from the giving of an opinion respecting the review and from the issuance or revocation of a *Financial Management System Certificate* unless these damages, costs, claims or causes of action result from gross negligence or bad faith; and
- 5. confirms that this resolution was approved at a duly called and conducted Council meeting of the Qalipu First Nation at which the required quorum of councillors was present throughout and that the required number of councillors approved the resolution at the meeting.

WHERE AS: QFN is committed to the broadest possible reach of information to our membership, and

WHERE AS: QFN is committed to maintain and build positive relationships with all audiences, and

WHERE AS: QFN desires to build, promote, grow and be a part of the Indigenous community in Newfoundland.

BE IT RESOLVED: that Qalipu First Nation Band Council direct our Senior Manager to investigate and report back to the Band Council at our next Regular Council meeting;

The steps and costs required to live stream the regular Band Council meetings to our membership via GINU or any other method that Senior Management wishes to advise

QFN band Council.
