Calibre is currently inviting applications for a **Heavy Equipment Operator Trainer** to join our growing team as the company transitions from mine construction to mine operations.

## **Heavy Equipment Operator Trainer**

The HEO Trainer has a primary responsibility to ensure that employees receive the knowledge and practical training to be a safe and productive Heavy Equipment Operator. This role will be required to develop the skills necessary to effectively teach Occupational Health & Safety related courses. Training must be completed in accordance with company Standards and Regulatory Legislation, while ensuring Heavy Equipment Operators have the skill level to accommodate the Mine site needs. The HEO Trainer must also develop/co-develop, monitor, communicate and ensure an understanding of Departmental Standard Operating Procedures (SOP's). The HEO Trainer will foster healthy relationships and maintain communications with all stakeholders of the operation to help ensure training needs are identified and addressed in a timely manner.

This position is located at the Project site, working on a 14 days in/14 days out rotation.

## Accountabilities/Responsibilities:

- Demonstrate leadership in Health, Safety, and Environment through personal behaviors and conversations.
- Establish and promote a respectful and healthy work environment at all times.
- Be a courageous health, safety, and environment leader, adhere to promote health, safety and environmental standards, policies and procedures.
- Organize and deliver effective classroom, practical field level functional competency, and followup training in a timely manner.
- Identify training needs for operational employees; primary focus on mine but may also be required to support other departments as needed.
- Develop and assist in the development, review, and revision of Heavy Equipment, OHS, Site and Company related training programs.
- Enhance training material through continuous improvement Incorporate new ideas, SOP's, changes, etc. to training materials.
- Liaise with Operational Departments to optimize training effectiveness and efficiency.
- Mentor and coach employees in the safe, effective and productive operation of heavy equipment.
- Evaluate employee performance and report findings.
- Provide follow up and refresher training to employees (safety and job specific).

- Assist in the delivery of orientation training to all employees, contractors, and visitors to site as scheduled.
- Assist in the delivery and/or development of specialized certification training such as Fall Protection, Confined Space, Power Line Hazards, First Aid, Overhead Crane, ETC...
- Ensure all training is in compliance with legislative requirements, and in conformance with company policies.
- Mentor employees in hazard identification, risk assessment and in reducing risk to "as low as reasonably achievable".
- Support supervisors in the development of a training plan for each employee and monitor that plan for conformance.
- Updates employee records.
- Adhere to all company policies and procedures.
- Perform other duties as assigned.
