Reporting to the VP of Safety & Compliance, the Senior IT Specialist is responsible for maintaining a variety of data communication networks and systems for Horizon Maritime and its group of companies by providing expert IT system support services across the organization. The successful candidate will be the single point of contact within the organization to facilitate IT project management, IT policy and procedure development, IT resource management and IT hardware installation. Furthermore, the Senior IT Specialist will actively communicate and liaise with all Horizon Maritime users including department heads, ships crew and external IT service providers.

This individual also assists with identifying, selecting and deploying new technology to support organizational goals and objectives, and will provide leadership in the continual improvement and implementation of existing systems.

The Senior IT Specialist responds to problems via the IT service desk, performs audits and inspections and is responsible for data security planning to ensure that Company's people and systems are protected. This role is extremely diverse and strategic in nature, but it will also require the successful candidate to balance and execute day to day operations including desktop support and troubleshooting while fulfilling longer term project deliverables.

- Minimum 5-10 years of progressive experience in IT supporting business operations required.
- Well experienced and proficient in PC, Mac and cloud computing environments, including Office 365.

- Experience identifying IT vulnerabilities and implementing controls to reduce risk.
- Experience developing and deploying IT policies and procedures.
- Knowledge of networking, operating systems and server architectures required.
