#### **Internship Position: Watershed Assessment Project Coordinator**

SAEN is a volunteer, non-profit organization dedicated to the conservation and wise management of our trout and salmon resources in Newfoundland and Labrador.

The Watershed Assessment Project Coordinator will contribute to watershed assessment and management planning for select salmon rivers on the Avalon Peninsula. This position will lead a review of existing information on selected watersheds and assist in developing a project plan for field surveys to be conducted. They will be responsible for organizing and participating in community meetings to gain knowledge on local factors that may be affecting salmonid populations; conduct research into effective watershed management plans being implemented elsewhere and make recommendations on elements to be considered in developing a project plan for selected watersheds; assist in field studies related to surveying habitat and collecting water quality data; provide associated reports and data to SAEN management; other duties as required.

#### **Activities and responsibilities:**

- Formal review of existing information on select watersheds and associated reporting
- Assist in developing field survey plans based on review and research
- Organizing and facilitating community meetings
- Watershed management research with report outlining recommendations for project plans
- Assist in field studies related to surveying habitat and collecting water quality data
- Administrative duties
- Other duties as required.

**Rate of pay: \$18.00/hr for 35 hours per week**

#### **Qualifications**

- Strong work ethic, attention to detail and excellent organizational skills
- Superior verbal and written communications skills
- Ability to manage priorities and balance workload
