First Nation Financial Management Board (FNFMB) Compliance

On an Annual basis, Chief and Council are required to re-sign the Conflict of Interest(COI) Declaration, COI Disclosure, and the FMB Code of Conduct Declaration. Councillors were emailed all documents which require a signature. Several Councillors members signed the documents at today's meeting. All required signatures have been received and recorded.

10-Year Strategic Plan

At a special meeting on Friday, February 5th, 2021 Council met to discuss and revise the current draft of the Strategic Plan. The plan guides Qalipu and can be amended as needed. It is a working plan which has had feedback from several consultations. A draft is on the website for review by membership.

All recommendations, made at Friday's February 5th meeting, have been made by Band Manager, Keith Goulding, and a final draft is ready for approval.

Following the AGA, held in Corner Brook in September of 2020, recommendations were made to revise the General By-Law. These edits have been completed and Council was presented with those changes at the meeting held on Friday, February 5, 2021. Band Manager, Keith Goulding noted that sections 4.8 and 4.9(a) & (b) were added to the By-Law and read those sections to the Council and to members listening.

Other Items to Discuss

Advisory Councils

This topic was added to discuss having advisory councils with regards to Youth, Elders and Women. It was noted that we have a current youth on Council, and we have a woman on council who is also an elder. It was advised that the Advisory Councils ought to be codified and there ought to be conversations in the future. Councillors agreed to create a committee to review Advisory Councils. Individuals who will serve on the committee are Councillor Odelle Pike, Councillor Ivan White SR, Councillor Jasen Benwah, Councillor Francis Skeard, and Youth Representative Sabrina Muise.

Election 2021

The next election must be no later than three(3) years from the last election and therefore will have to be scheduled on or before October 22, 2021. The plan is to start promoting the election early by promoting how to vote, promoting electronic and telephone voting, and promoting the benefit of having GINU updated. It was also noted that to apply to be a Ward Councillor, you must live in the ward, be 18+ years of age, obtain two signatures from an elector (18+ years of age), and pay a fee.

Improved access to Council Meetings

Members have expressed concerns trying to find the Council Meeting Minutes and other valuable information on the Qalipu Website.

The website was last updated several years ago, Band Manager indicated that the website does require revisions.

Social Economic Agreement (SEA) - Marathon Gold

It is important to note that Qalipu First Nation has not signed a SEA with Marathon Gold. Qalipu is involved in hearing the concerns of members and will decide on the signing of the SEA at a later date.

Following a brief discussion of topics of interest at various consultations, Councillor Frank Skeard made a motion.

Committee Updates

Five(5) committees submitted a written report as part of the Council Kit. The chairs of the committee's were provided an opportunity to briefly detail the report and address questions of Council.

Finance & Audit Standing Committee (FASC)

Vice-Chief Randy Drover began by noting that the Director of Finance, Ms. Jodie Wells, will be leaving Qalipu for a new position with Indigenous Services Canada (ISC) and Ms. Karen Tiller is now the Finance Manager for Qalipu. Mr. Drover then discussed the FASC minutes of February 1, 2021.

FAC Meeting Minutes – February 1, 2021

Mr. Drover highlighted important information from the meeting and discussed several Budgets. While reviewing Covid-19 funding and the amounts previously given to Community Groups, a new program beginning at end of month will be initiated. A surplus of funds in Education and Training will create new funding programs - Budgets to be developed by Ms. Monique Carroll, Director of Education and Training. Funding programs discussed include: Mature Student Funding Programs; Central K-12 Funding Program; Pre-School Program; Financial Literacy Program/Workshops; Life-Skills Workshops; Work-term Partnerships; Child-Care Program; Travel Program; and Cultural Workshops.

The next meeting of FASC is scheduled for February 19, 2021 and Breakfast Programs can be discussed.

Communications Committee

Prior to the meeting, Councillor Odelle Pike presented to Council a Communications Report with the Terms of Reference(TORs) and the Communications Plan Template attached as subsequent documents.

Sections of the report were read, and recommendations were made. The TOR, as revised, to be signed by Band Manager. The template for QFN Strategic Communication Plan was accepted by Band Manager and Communications Officer given direction to proceed with writing the document.

Education & Training Standing Committee

Councillor Odelle Pike read and summarized all projects in the Education & Training Department. She indicated that the committee discussed funding opportunities for students currently enrolled in school and currently receiving funding. The committee recommended that some of the surplus, discussed in the Finance Committee Report, should go to these students.

FASC to review recommendations from the Education & Training Committee.

Natural Resources & the Environment Standing Committee

As previously stated, the report was provided to Council prior to the meeting. Councillor Frank Skeard's report highlighted activities and action items of the committee. The following comments were made:

- Prospectors Course Frank Skeard, chair of the NR Committee, the Education & Training Department, and NL Prospectors Association will work together to offer the course.
- > SEA with Marathon Two QNR representatives will be amongst the Engagement & Environmental Stewardship Committees.
- > Red Fish This file is with QDC; however, it is categorized under QNR.
- Traditional Territory Map More information should be posted in a couple of weeks.

Councillor Skeard requested if there were any further comments or questions to contact him directly. The next meeting is scheduled for Friday, March 19, 2021.

Community Development Standing Committee

Councillor Keith Cormier, Chair of the committee, provided updates in addition to the written report.

- > The MMIWG Project will aim to conclude in the spring to be ready for June 21st, 2021.
- Language Project, with Dean Simon, is going well. Online reach is close to ten thousand (10K)
- Wigwam Point land grant application is a project of the Committee
- > Cultural Foundation's online auction will end on Sunday

Youth Representative

Sworn in on December 12, 2020, Ms. Sabrina Muise updated Council on activities of the youth in the past three months. She handed out an overview of her report and briefly explained how the current Youth Council will be created and how they will engage and make decisions. The youth have held online events and Ms. Muise provided Council with the feedback from participants who attended those sessions. The report provided information regarding the four proposed Governance Structures and the Youth Council election process. Ms. Muise informed Qalipu Council that the youth have received government funding with the intent of using it for the Youth Council Election.

With respect to Lateral Kindness/Violence Training, Band Manager, Keith Goulding indicated that he has funding available for Lateral Violence Training and Youth can participate. Also, Councillors asked Ms. Muise along with the Youth Council to submit a Request for Donation to the Band Manager.

Band Manager Report

With regards to the recent report submitted, the following updates were provided:

- > RFP for Traditional land Use will be completed by end of February
- Executive Committee will aim to meet with the three community Chiefs in Flat Bay Ward in March
- > 10-year anniversary of the Band there will be an event in September
- Letters of Support for an Urban Reserve letters received from Government of NL and Miawpukek First Nation(MFN)
- Meeting with QCF Has been postponed, no new date set

Executive Committee Report

Since the submission of the report, Chief Mitchell provided to Council the following updates:

- > COVID Vaccinations Chief Mitchell has made contact with government officials
- > Enrolment no new updates on the court case
- Mi'kmaq Grand Council Flag Raising Ceremony held at Grenfell Campus on Saturday, January 30th; MUN wants a similar ceremony in St. John's
- Letter of Support for PET Scanner letter drafted, edited, signed and submitted
- ➤ Aboriginal Sport Circle the process of who will purchase and store the equipment is still not determined. The money is currently held in trust Qalipu does not have access to the funds, it is not in our account or in our budget.

Council Remarks

Councillors were asked to update each other on activities within their communities and the Youth Representative was asked if she had any other info to add to her report.

Ivan J. White: To Sabrina - Applaud results and your courage; you have exhibited empathy and compassion.

Ivan White, SR: Three bands in the Ward are busy with food initiatives. Have had meetings to discuss areas of concern and will continue meeting with the three bands in the ward.

Bern White: In process of having the Benoit Cove Band up and running. With regards to Pinchgut Lake land - a discussion needs to be had.

Jasen Benwah: Been communicating with the Veterans. Those just approved for status under Wells Case, are still waiting for letters and cards – Who do these individuals speak with?

Sabrina Muise: The courage and the strength provided comes from the Youth Council.

Randy Drover: Do not intend on running in the next election. Will work the next three(3) months to finish up projects and will seek further education.

Odelle Pike: Been busy and engaged in the community and will know more soon about several projects.

Brian Dicks: Have had numerous member requests for information on Education and Health Funding. Was contacted by a local Tourism group who seeks Funding. Grenfell made contact regarding developing a Housing Research Hub focussing on Indigenous Housing. Worked with Sherry Dean and the Corner Brook Aboriginal Women's Association regarding funding. A warm welcome to Sabrina and your representation of the Youth.

Andy Barker: No Comments

Frank Skeard: In Glenwood Ward, there are a lot of activities in support of Qalipu First nation; There are several grassroots organizations focussing Culture and Heritage. Working to support the membership whom he represents. Have had requests for the Executive to visit the Glenwood Ward. As Chair of NRSC committee, there is a recognition for significant opportunities regarding economic development.

Keith Cormier: Thanks to everyone for the work completed in the last two days. Safe travels and
