Briefing Note- Amendment to Section 5.1 of Council Procedures Motion 03-2023-2024

Charles Pender, Band Manager, discussed the proposed amendment to council procedures. Current procedures only required 7 calendar days of supplied material and council had previously requested the material be supplied within 10 days. The recommendation was to amend section 5.1 of council procedures to comply with council's request.

Charlene Combdon also requested the procedures be updated with gender inclusive language. Charles Pender stated the executive committee could handle the modification of the language. Charles Pender clarified that under policy review, there is an initiative for the executive committee to review all policies to utilize gender inclusive language.

Committee Updates

Health and Wellness- Chair Sherry Dean provided an update on activities. They are working a 10-year strat plan. One of the main concerns is wait times for travel reimbursement. There was some discussion about moving Housing into another Committee.

A discussion occurred around proposal writing and the need for a staff member to be devoted to seeking funding opportunities.

Committee Updates Resume

The committee updates began following the break for lunch at 12:45 pm.

Culture, Tourism, and Community Development- Just finished land camps which was a success. Learning camps are going off-line, as part of the camp, there will working with DFO. The department is also consulting with elders and community leaders.

Terri Greene asked about expansion of camps to other areas/ wards. Kellie Kerpan explained the current funding supplied was for the central region, but funds have been allotted to support travel from the Western region. The department is working to expand the program to other locations.

The department has expanded their workshops offering to a wider range of communities.

Communications and Operations- Held their meeting in April. Looking for funding arrangements for summer student to create a video project. Charles and Alison looked at RFP offers for diagnostic and communications plan. The offers received did not have any education or work experience in the field, maybe changing the language to see if that improves submissions.

Charlene Combdon discussed two members who she knows personally from Jackson's Arm, Roddy and Randy House. Both were in Ottawa to receive the Order of Military Merit.

Finance- Director Andrew Simmons provided an update. The department is currently implementing their new accounting system. The hope is the improve efficiency will improve wait times for travel and education funding reimbursements for membership.

July meeting with include meeting with auditor to review 2022-2023 finalized financial statements. They will have been reviewed by the department and finance and audit committee.
