Councillor Sherry Dean shared that a Housing Manager and Housing Officer had been hired permanently for the Housing division in Health and Wellness. Also, a new Jordan's Principle Coordinator had been hired as well.

Councillor Charlene Combdon expressed that there is high need of housing in central Newfoundland as well as for an Indigenous Patient Navigator. Band Manager Charles Pender stated that the new programs are in the works, and we will expand as we grow over time based on the availability of funding and to put where the need is highest first, then work our way out.

Councillor Frank Skeard stated that strategic planning and collaboration committee are having conversations regarding an Indigenous Patient Navigator in the two regional centers. Councillor Terri Greene also stated that regional health centers are changing and going forward, we need to be ready.

Councillor Calvin Francis made a statement saying Gander Bay has the need for housing and supports what is being proposed and the potential expansion of the program. Councillor Sherry Dean replied saying once funding is approved it will be available to all members.

Councillor Hayward Young brought attention to Council about a survey done online and it was supported over 90% that was against hook and release. He got information saying Qalipu is not supporting hook and release. He stated we need another survey sent out to find out more information.

Band Manager's Update

Band Manager Charles Pender provides the following updates:

- Qalipu Community Room has been relocated and renovated on the lower level of 1 Church Street in Corner Brook. Looking into more funding to create a more accessible room.
- Received the quote to build new offices in the empty space in the upper floor, waiting on the permits.
- Storage room on the upper level has been renovated to create additional space.
- Some staff have been relocated to new office spaces.
- Community Conversations went ahead in Port au Port, Meadows and Badger.
- Mou with CNA has been signed and approved.

It was mentioned from Council on building stronger relationships within ward communities.

Director of Finance Andrew Simmons stated that language funding is coming to the end of the year. Trying to work with the funder to extend program. Received money from tech resources agreement but need to clarify eligibility for spending since it only began in November.

Councillor Frank Skeard asked if auditing is being done for projects with large budgets. Director of Finance Andrew Simmons stated that an annual external audit performs a service that is approved every year by council and this review helps to flag any issues that arise.

Councillor Sherry Dean asked for plans for the summer youth camps, Councillor Charlene Combdon will have more information on that in the next committee meeting.

Councillor Charlene Combdon asked if funding is secured for North American Indigenous Games. Director of Finance Andrew Simmons stated every year they get Council to approve a specific amount. By the fourth year for the games, the pot will be big enough for the donation. Amount will be confirmed and included in the budgeting process. Working on the existing budgets for the Aboriginal Sports Circle for Canada Games in 2025.

Other Items

1 member in attendance asked council a question regarding the status on the youth representative.

Former youth representative took a leave of absence, Councillor Ivan J. White states he will reach out to Education and Training for more information.

Councillor Terri Greene made a statement saying that she wants to assist with getting a youth representative.

Next meeting date is tentatively scheduled for Saturday, March 23^{rd,} 2024.

Adjournment- Councillor Terri Greene made a motion to adjourn the council meeting.
