Early Salary Review

- Councillor Sherry Dean brought this to the council meeting because she felt we are not keeping pace with inflation. We have lost employees due to salary.
- Councillor Frank Skeard did not understand the package our staff receives.
- Councillor Frank Skeard felt we need to look at compensation and not salary. Need more of an assessment.
- Director of Finance Andrew Simmons said in 2022 a salary classification was done;
 Council approved a salary structure. 10 different steps in salary scale. Individual gets placed on 1-10 scale. 30% difference in step 1-10; 3.33% increase annually that

- employees are eligible for. Giving Directors time to review job descriptions for certain positions.
- Councillor Charlene Combdon is concerned about an early salary review and that it may have an impact on the organization.
- Band Manager Charles Pender confirmed the HR review has started.
- Councillor Sherry Dean stated there are multiple staff at Qalipu that work part time jobs to pay rent.
- No motion needed, just a discussion.

Band Council Orientation

- All councillors agreed one day of orientation is not sufficient.
- Councillor Charlene Combdon did not attend orientation because she was elected in a by-election. Orientation should wait until the by-election ends.
- Chief agreed it is important to know our roles and responsibilities when hired and fully understand our positions.
- Councillor Terri Greene stated that mock/training sessions are great for orientation.

Amended TOR for Culture Tourism and Community Development Standing Committee

- Chief Brake stated the Terms of Reference was reviewed before Councillor Frank Skeard became the Chair.
- Chief Brake informed Council that Band Manager Charles Pender is acting Director for Culture, Tourism, and Community Development.
- Director of Finance Andrew Simmons stated no employees should have a vote on any committees-only for recommendations.
- Councillor Frank Skeard to have a meeting with the Culture, Tourism, and Community Development Standing Committee to get amended Terms of Reference.
- Councillor Frank Skeard and Councillor Charlene Combdon will email Band Manger
 Charles Pender the Terms of Reference and the Member at Large by the end of the week.
- Councillor Charlene Combdon requested a meeting as soon as possible to get the Terms of Reference completed.
- Chief Brake stated once the Terms of Reference are complete, Council will meet again to ratify.
- A motion will need to be put forward to complete.
- Councillor Bobby White joined the meeting at this point approximately 7:30pm.

Appointment of Member at Large for Culture, Tourism and Community Development Standing Committee

- Chief Brake stated that Councillor Frank Skeard and Councillor Charlene Combdon will need to hold a committee meeting to make a recommendation on the Member at Large.
- Once a recommendation is made Council will meet again to approve.

FAC Committee Members

- Councillor Terri Greene stated there are two meetings left for the FAC Committee.
- Opportunity for a fourth member on the committee.
- · Update the standing committee form.

Org Chart Approval

- Councillor Charlene Combdon found errors in the org chart.
- Cultural Liaison Officer to be changed to Cultural Outreach Officer.
- Councillor Frank Skeard asks to see the new positions on the chart to be highlighted.
- This item to be moved to the next meeting of Council.

Naming the Community Room

- Chief Brake would like to name the Community Room after a staff member who passed away.
- Councillor Andy Barker wanted to know if Community Room is the Council Chambers.
- Councillor Charlene Combdon believes there should be a Council Chambers.
- Band Manager Charles Pender stated the Community Room is used by the public 80% of the time.
- Councillor Andy Barker suggests putting forward nominations to name the Community Room.
- Chief Brake stated this should be done through the Culture, Tourism, and Community Development Standing Committee.
- Councillor Frank Skeard and Councillor Hayward Young stated they would like to see a Community Room for each ward.

Schedule of Municipal Visits/Virtual Meetings

- Chief Brake would like Councillors to reach out to their Municipal leaders to establish a relationship.
- Councillor Terri Greene and Councillor Bobby White believe monthly meetings would be very difficult to arrange.
- Councillor Jasen Benwah thinks Qalipu could start on a municipal level as well as reaching out.
- Councillor Charlene Combdon stated we should take time to invite the Mayor and speak about what the Band does and the impacts on the Community.
- Chief Brake stated that if you need help reaching out to their Municipalities, bring it forward and we can discuss.
- Councillor Frank Skeard was absent for the vote.

- Chief Brake stated AFN has a youth committee instead of a youth representative at Council.
- Chief Brake stated this is not functioning as we would like it to.
- Councillor Charlene Combdon mentions that Councillor Ivan J White may have connections regarding a Youth Council with the Education and Training Department.

Adjournment – Calvin Francis made a motion to adjourn the council meeting. Councillor Sherry Dean Seconded the motion.
