# **Process Plant Supervisor**

Reporting to the Process Plant Superintendent, the Process Plant Supervisor is responsible for the supervision and coordination of Process Plant Operators. The Process Plant Supervisor is responsible for meeting production targets and quality standards while fostering a health and safety culture of Zero Harm while ensuring compliance with regulations and company standards.

This position is located at the Mine site, working on a 14 days in/14 days out rotation.

# Accountabilities/Responsibilities:

- Promotes continuous improvement and maintains a safe work environment, safe work practices, and a strong safety culture, holding crews accountable for working safely.
- Leads by example and provides Process Plant Operations crew with supervision, coaching and mentorship supporting safety and mill production initiatives and ensure compliance with policies, procedures, and safe work practices ensure the production and development targets and schedules are met.
- Ensures all employees have all the necessary skills, training, and knowledge to perform their assigned tasks safely and efficiently.
- Works with technical personnel in determining the overall strategy for the Process Plant.
- Provides input and guidance to help identify and minimize risks and define action plans and improvement and cost-saving opportunities (continuous improvement practices).
- Communicates production and safety goals with the crews.
- Leads troubleshooting initiatives and engages appropriate cross-functional resources to analyze and correct operational and equipment problems.
- Report results, issues, and problems to the Process Plant Operations Superintendent.
- Leads effective incident investigations, implements corrective actions to prevent re-occurrences and develop particle and safe operating solutions.
- Exercises effective employee relations strategies to manage employee concerns and performance-related issues and develop performance plans.
- Champion's safety and identifies hazards and promotes safety awareness and compliance through day-to-day attitudes and actions.



- Maintains compliance and ensures adherence to policies, procedures, legislation, and regulations pertaining to the mining industry.
- Performs other related duties as assigned.
