Further resolved that for the purpose of quorum, Council member who declares a conflict of interest or who is declared to be in a conflict of interest by the Council on a matter before the Council shall be required to leave the meeting for the discussion on that matter.
- Councillors Andy, Charlene, and Frank expressed concern about lowering quorum.
- No members were in favour and the motion was not carried. Quorum will stay at 7 members of Council.

- Director Finance Andrew Simmons stated that the general bylaws reference that if a Band Council member fails to attend 3 consecutive meetings, there is ability to remove them from Council. The custom election code supersedes the ability to do so, but the briefing note can provide an option to Council to enforce the section of the general bylaw.
- Councillor Sherry Dean stated the motion "Be resolved, that effective immediately, any
 member of Council who has 3 consecutive uncommunicated absences from regular
 Council meetings, shall have their honorarium suspended and shall not be eligible for
 appointment as a Qalipu representative on any committee or to a convention or meeting
 conducted outside the Councillors electoral ward. With a suspension lifted and eligibility
 reinstated upon a further motion being passed by Council. Once the member of Council
 resumes attending Council meetings on such terms Council deemed appropriate."
- Councillor Frank Skeard voted against the motion.

- Central Vice Chief Andy Barker stated that the data regarding to age, demographics, housing, and family composition is more oriented towards reserves and not our own community.
- Central Vice Chief Andy Barker expressed that the Health and Wellness program has low responses and Council needs to be pushing the agenda.
- Councillor Charlene Combdon stated that Grand Falls-Windsor has a lack of consult with the local community groups and Gander Bay is not listed. There are barriers for our membership travelling into the larger centers to have their voices heard and shared in the data.

- Director of Finance Andrew Simmons stated the engagement on this feedback is higher than previous initiatives.

Band Manager Report:

- Chief Brake informed that they are continuing to work closely with the town of Peterview regarding Wigwam Point.
- Director of Finance Andrew Simmons stated the Governance policy, Bylaws, and HR are continuing to be reviewed. Working with a HR consultant MNP on how to better utilize our HR software and working on a staff satisfaction survey to collect feedback prior to the full HR policy review.

Council Remarks

- Councillor Bobby White said summer is good so far and community is well. They are looking forward to more information being brought back. Currently a new Band office is being built for his community.
- Councillor Charlene Combdon sends condolences to the Kelly and Ansty family for the loss of Chris from Gambo. He was a Qalipu member and offered many workshops throughout the community.
- Councillor Sherry Dean sends condolences to Councillor Hayward Young whose sister passed away recently. In Corner Brook their Elmastukwek Mawio'mi will start in August. She

- Chief Brake said she has been around in many communities and speaking to members. Said we need to keep each other in mind and thanks for everyone's dedication and care that we give to the people that we serve.
