- Councillor Calvin Francis is not in agreement and stated the next council will have the opportunity to discuss.
- Councillor Sherry Dean sees this as an opportunity to be proactive by setting our next Council to be protected.

# Committee Updates

#### **Education and Training**

- Councillor Ivan J. White stated there are 10 students attending Law School. 3 graduating in 2024 and 2 next year.
- Many members have been funded for Med School hoping to potentially partner with NL Health.

#### Health & Housing

- Councillor Sherry Dean informed that the Health and Wellness Department has increased capacity.
- The turnover rate for NIHB is now approximately 3 weeks, down from 12 weeks last Fall.
- The Department held their first Housing Forum last week and hopes to have another in the Spring.
- Every Municipality is reviewing their own responsibilities to their own Emergency Preparedness Plan.
- Housing Department liaised with Emergency Preparedness Department of Government, and they will coordinate if there are any changes to that system moving forward.
- Councillor Sherry Dean stated we are looking for more Mental Health Councillors for the Stephenville area.
- Councillor Shery Dean strongly suggests this next Council to write the department of Health to strongly suggest bringing specialists to the West Coast.

#### **Environment and Natural Resources**

- Environmental Stewardship Program with Calibre Mining grant research program has started.
- Environmental technician hired and will be in contact with the departments with any issues.
- Calibre subcontracts small projects to do research on Environment MALS beginning February. Four contracts will come to Qalipu.
  - o Pine Martin study February-March
  - Birds May-July
  - o Bat monitoring May-October
  - o Country Foods, Berries, Fish and other animals after that.
- Vice Chief Andy Barker requested a motion be made to ensure the hire of two River Guardians.

# Recommendation to Hire of 2 River Guardians for the Exploits River Motion 33 - 2024-2025

Moved by:	Andy Barker	Seconded by:	Robert White
Motion Carried	All in favour	Ten (10)	Zero (0) Against

- Vice Chief Andy Barker stated the Exploits River has the largest watershed with no fisheries guardians. He proposed to see the 2025-2026 budget to hire two additional Fisheries Guardians. If funds are not granted the funding should come from Qalipu First Nations own source of funds.
- Councillor Frank Skeard would like to see the River Guardians term be increased from 16 weeks to 32 weeks.
- Motion carried.

#### Band Manager Report:

- Band Manger Charles Pender stated that Wigwam Point is working with the consultant to complete the application to ACOA.
- Business forum coming up later in the year in Gander, Stephenville and Corner Brook with a Culinary Event.
- Nominations for the election open September 23 and close October 1.
- Voting opens October 18 and closes October 25. Results will be issued shortly after.
